

# Central Valley Coin & Collectibles Show Bourse Application

## August 1 & 2, 2025

Veterans Hall, 3500 Coffee Rd. Modesto, California

1. Early setup: 4 to 8 pm on Thursday, July 31, 2025. Pizza and sodas will be provided!
2. Dealers: Doors open at 7:00 am on Friday and Saturday for setup.
3. Show hours: 10 am to 6 pm on Friday, August 1, 2025, and 10 am to 5 pm on Saturday, August 2, 2025.
4. Tables are 8 feet with back up tables. Dealers will provide their own cases and lights. A limited supply of display cases at \$20 each and lamps at \$10 each are available for rent. Plastic table covers will be provided. Dealers will be provided with electrical outlets.
5. Bourse fees for the 2-day event are \$400.00 for the first 8-foot table, and \$300.00 each for additional tables.
6. All dealers must be at least 18 years old and agree to comply with all local, state and federal laws.
7. Bourse tables shall not be resold, rented, loaned, or shared without prior consent of the Bourse Chair.
8. The Bourse Chair will make all table assignments, giving priority to those who pay earliest.
9. All dealers will be provided with badges. These badges **MUST** be worn while the dealer is in the Bourse Area. **NO ONE** will be permitted behind bourse tables without a dealer's badge. In addition, dealer badges will be issued **ONLY** to the individuals listed on this application. Two badges will be issued per table.
10. The show will open to the public on both days at 10 am. One-hour early entry badges can be purchased for \$25.00.
11. **Armed Security will be provided** for the show, starting at 3 pm on Thursday, 7/31/25, and lasting until 6 pm Saturday, 8/2/25. Each dealer will be responsible for his/her own merchandise and agrees not to hold the Stanislaus County Coin Club, the Central Valley Coin Club, the Delta Coin Club, the Stanislaus County Veterans Hall, the Bourse Chair or any officers, members or associates of the prior listed organizations, liable or responsible for any loss, theft, damage or injury to person or property during the duration of the show. Each dealer is responsible for his/her own insurance.
12. Refunds for cancellations must be requested at least two weeks prior to the show and must be approved by the Bourse Chair.
13. Donuts and coffee will be provided for dealers each morning, and food may be purchased nearby.
14. Your signature on this application indicates your agreement with these rules and regulations. Cut off the bottom portion, remit with payment, and keep the top portion for your reference. Please notify us in advance if any additional accommodation is required.
